We want to thank all the nursing facilities for their increased participation in PA Health & Wellness' Quality Incentive Program (QIP) during the quarter 4, 2022 measurement period.

The purpose of this email is to provide program updates effective January 1, 2023:

- **Requirements for participation in the program and incentive payment will remain unchanged at this time.** We will be evaluating potential enhancements to the program; however, any changes will be considered during the program anniversary on 7/1/2023.
- **The incentive payment amount is changed to 1.85% effective January 1, 2023.**
- **We will be mailing updates to all nursing facilities by January 9 regarding their participation in the incentive payment for the first quarter of 2023.**

**As a reminder, to receive the payment incentive for the second quarter of 2023, Nursing Facilities must complete the following:**

1. Supply Participant Information, including:

  - Due the 5th calendar day of the following month. **Next due on 1/5/23.**

- [Nursing Facility Ineligible \(NFI\) Admit Notification](#)
  - Due the 7th calendar day after the NFI admission
  - Completed excel file should be sent to [NF@pahealthwellness.com](mailto:NF@pahealthwellness.com)
  - Instructions for **identifying NFI dual eligibility** for both found here <https://www.pahealthwellness.com/providers/resources/NursingFacility.html>.
- Copies of PA162 forms (most updated version must be on file, only resubmit if there are changes) submitted to [PA162@PaHealthWellness.com](mailto:PA162@PaHealthWellness.com).

2. Documented participation in PA Long Term Care Learning Network

- 1 training per facility required for 2023 (tracked by NPI)
- **NPI must be used when registering for training to receive credit for attendance**

3. Provide Electronic Medical Record (EMR) access.
