These are the types of flu that are responsible for seasonal flu epidemics each year and determine how flu vaccines are made</li> <li>Flu can cause mild to severe illness, including death</li> <li>The best way to prevent flu is by getting a flu vaccine each</li> </ul>

	<ul> <li>year</li> <li>Nationally Respiratory Illness causing people to seek healthcare is low.</li> <li>Flu Season ended May 17, 2025</li> <li>Lyme Disease</li> <li>Some key points: <ul> <li>Pennsylvania leads the nation in Lyme disease infections</li> <li>Late spring into summer is the season for high tick activity</li> <li>Ticks usually attach themselves in areas that are more hidden or hairy, such as your head, groin area, and armpits</li> <li>Lyme disease affects humans and pets</li> </ul> </li> <li>Early Signs and symptoms of Lyme Disease:</li> <li>Occurs in approximately 80% of people who are bitten 3-30 days after tick bite</li> <li>Fever, chills, headache, fatigue, muscle and joint aches, and swollen lymph nodes may occur in the absence of rash</li> <li>Bull's-eye rash may appear at about 7 days after bite on any part of the body, but not always. May gradually get bigger</li> <li>May feel warm to the touch but is rarely itchy or painful</li> <li>May appear on any area of the body</li> </ul> Some later signs and symptoms of Lyme Disease: <ul> <li>Severe headaches and neck stiffness</li> <li>Loss of muscle tone or droop on one or both sides of the face</li> <li>Arthritis with severe joint pain and swelling, particularly the knees and other large joints</li> </ul>

HEDIS Operations	<ul> <li>Shooting pains, numbness, or tingling in the hands or feet Penn State has a kit where you can remove the tick and get it sent out to be tested for Lyme Disease for \$18.</li> <li>What to do after a tick bite: <ul> <li>Remove attached ticks as soon as possible. As a word of caution, do not use petroleum jelly, heat, nail polish, alcohol, lighted match or heated tweezers, or other substances to try and make the tick detach from the skin. This may agitate the tick and force infected fluid from the tick into the skin</li> <li>Call your doctor if you develop a fever, rash, or other symptoms</li> </ul> </li> <li>Treatment is antibiotics once you are diagnosed.</li> <li>Remove ticks immediately!!</li> <li>Susan will get vaccine schedule out as well.
