In keeping with our commitment of promoting continuous quality improvement for services provided to PA Health & Wellness members, effective March 1, 2024, PA Health & Wellness has partnered with Evolent (formerly National Imaging Associates, Inc.) to implement a Musculoskeletal (MSK) Management Program. This program includes prior authorization for non-emergent **MSK procedures including inpatient and outpatient hip, knee, shoulder, lumbar and cervical spine surgeries**. This decision is consistent with industry-wide efforts to ensure clinically appropriate quality of care and to manage the increasing utilization of these services.
