This agreement signifies tango's appointment as the delegated manager for Wellcare By Allwell's skilled home health benefit, specifically for the following Wellcare By Allwell's Medicare Advantage members:

- HMO
- HMO - Dual Special Needs Plan

The expanded partnership encompasses several key components that aim to enhance the quality and delivery of skilled home health care for Wellcare By Allwell members:

1. Network Development and Management:
 - Developing, maintaining, and credentialing a robust network of skilled home health care providers.
2. Referral Coordination and Authorization Management:
 - Efficient management of skilled home health referrals, referral coordination, and authorizations.
3. Claims Payment:
 - Timely and accurate claims payment for the services provided under this delegation.

tango's delegated services will include the following:

Please note that while tango does not authorize behavioral health, respiratory therapy, or home infusion therapy nursing services, we can provide you with contact information for providers offering these services. Beginning on 10/1/2025, home infusion therapy services must be coordinated directly between agencies and pharmacies except for those members who are transitioning care.

Our shared focus is on ensuring that members receive exceptional care in the comfort of their homes while reducing avoidable readmissions and emergency department utilization.

We understand the importance of a seamless transition for Wellcare By Allwell's Medicare Advantage Dual Special Needs Plan members and we strongly encourage your organization to apply for participation in tango's skilled home health network. As part of our commitment to fostering collaboration and driving quality care, tango proudly offers innovative payment opportunities through value-based programs for qualified agencies,

contributing to our collective mission of reducing the total cost of care through high quality skilled home health services.

Member support for continuity of care

To ensure continuity of care for members, Wellcare By Allwell members, tango and WellSky are working closely together to facilitate a smooth transition. On 10/1/25 any skilled home health agency not already contracted with tango for the services mentioned above will be considered out-of-network for Wellcare By Allwell members.

However, members who are already enrolled in a skilled home health episode as of 10/1/2025 may continue receiving those services through the end of the Wellcare By Allwell authorization period. If additional visits are required for that authorization period, those requests should be directed to Wellcare By Allwell

After the end of the authorization period, a request must be made to tango for continued services. Out of Network agencies will be offered the opportunity to join the network or will be required to transition the member to an in-network provider at the end of the certification period.

For all authorization requests related to new skilled home health services starting on or after 10/1/2025 please direct them to tango.

Please note authorizations linked to a WellCare by Allwell episode should be billed to WellCare by AllWell through the 10/1/2025 go-live date. Authorizations associated with a tango episode should be billed to tango.
