

## Clinical Policy: Furosemide (Furoscix, Lasix ONYU)

### Description

Furosemide (Furoscix<sup>®</sup>, Lasix<sup>®</sup> ONYU) is a loop diuretic administered via a wearable, single-use, pre-programmed Infusor for outpatient self-administration.

### FDA Approved Indication(s)

Furoscix and , Lasix ONYU are indicated for the treatment of congestion due to fluid overload in adults with chronic heart failure (CHF).

Furoscix is additionally indicated for the treatment of edema in adult patients with chronic kidney disease (CKD), including the nephrotic syndrome.

### Policy/Criteria

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.*

It is the policy of PA Health & Wellness<sup>®</sup> that Furoscix and Lasix ONYU are **medically necessary** when the following criteria are met:

#### I. Initial Approval Criteria

##### A. Heart Failure or Chronic Kidney Disease (must meet all):

1. Diagnosis of one of the following (a or b):
  - a. Furoscix or Lasix ONYU: CHF;
  - b. Furoscix only: CKD;
2. Prescribed by or in consultation with one of the following (a or b):
  - a. Furoscix or Lasix ONYU: cardiologist;
  - b. Furoscix only: nephrologist;
3. Age  $\geq$  18 years;
4. Provider attestation that member is showing signs of extracellular volume expansion due to CHF or CKD (e.g., jugular venous distension, pitting edema [ $\geq$  1+], abdominal distension, pulmonary congestion on chest x-ray, pulmonary rales);
5. Documentation that member is a candidate for parenteral diuresis outside of the hospital, as defined by all of the following (a, b, c, and d):
  - a. Oxygen saturation  $\geq$  90% on exertion;
  - b. Respiratory rate  $<$  24 breaths per minute;
  - c. Resting heart rate  $<$  100 beats per minute;
  - d. Systolic blood pressure  $>$  100 mmHg;
6. Provider attestation that member will use Furoscix/Lasix ONYU for short-term use only and will be transitioned to oral diuretics as soon as practical;
7. Member has been stable and is refractory (as defined by *Appendix D*) to at least one of the following loop diuretics, at up to maximally indicated doses (a, b, or c):
  - a. Furosemide oral tablets;

- b. Torsemide oral tablets;
- c. Bumetanide oral tablets;
- 8. Dose does not exceed one of the following (a or b):
  - a. Furoscix (i and ii):
    - i. 160 mg (2 cartridge) per day;
    - ii. Total of 8 kits over 30 days\*.  
*\*more than 8 kits in 30 days will be reviewed on a case-by-case basis.*
  - b. Lasix ONYU (i and ii):
    - i. 160 mg (2 cartridges) per day;
    - ii. Total of 1 Starter Kit and 13 Lasix ONYU Kits over 30 days.

**Approval duration: 4 weeks**

**B. Other diagnoses/indications**

- 1. Refer to the off-label use policy if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): PA.CP.PMN.53

**II. Continued Therapy**

**A. Heart Failure or Chronic Kidney Disease**

- 1. Re-authorization is not permitted. Members must meet the initial approval criteria for each request.

**Approval duration: Not applicable**

**B. Other diagnoses/indications (must meet 1 or 2):**

- 1. Currently receiving medication via PA Health & Wellness benefit and documentation supports positive response to therapy or the Continuity of Care policy (PA.PHARM.01) applies.

**Approval duration: Duration of request or 6 months (whichever is less); or**

- 2. Refer to the off-label use policy if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): PA.CP.PMN.53

**III. Diagnoses/Indications for which coverage is NOT authorized:**

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – PA.CP.PMN.53.

*This table provides a listing of preferred alternative therapy recommended in the approval criteria. The drugs listed here may not be a formulary agent and may require prior authorization.*

Drug Name	Dosing Regimen	Dose Limit/ Maximum Dose
bumetanide (Bumex <sup>®</sup> )	0.5 to 2 mg orally per day	10 mg/day
Furosemide (Lasix <sup>®</sup> )	20 to 80 mg orally per day	600 mg/day
torseamide (Soanz <sup>®</sup> )	10 to 20 mg orally per day	200 mg/day

Therapeutic alternatives are listed as Brand name<sup>®</sup> (generic) when the drug is available by brand name only and generic (Brand name<sup>®</sup>) when the drug is available by both brand and generic.

*Appendix C: Contraindications/Boxed Warnings*

- Contraindication(s): anuria; hypersensitivity to furosemide, components of the formulation, or medical adhesives
- Boxed warning(s): none reported

*Appendix D: General Information*

- Definition of disease refractory to loop diuretics
  - Failure to relieve volume overload, edema, or congestion despite a full dose of loop diuretic. Full dose of loop diuretic is defined by oral furosemide 80 mg daily or equivalent. The approximate dose conversion ratio for bumetanide: torseamide: furosemide is 1:20:40.

Drug Name	Indication	Dosing Regimen	Maximum Dose
Furoscix	CHF, CKD	80 mg SC once over 5 hours	80 mg/day
Lasix ONYU	CHF	80 mg SC over 5 hours. Administer once or twice daily as needed for edema.	160 mg/day
