

## Clinical Policy: Thyroid Hormones

### Policy/Criteria

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.*

It is the policy of PA Health & Wellness<sup>®</sup> that Thyroid Hormones are **medically necessary** when the following criteria are met:

### I. Requirements for Prior Authorization of Thyroid Hormones

#### A. Prescriptions That Require Prior Authorization

Prescriptions for Thyroid Hormones that meet any of the following conditions must be prior authorized:

1. A prescription for a non-preferred Thyroid Hormone.
2. A prescription for a preferred Thyroid Hormone with a prescribed quantity that exceeds the quantity limit.

#### B. Review of Documentation for Medical Necessity

In evaluating a request for prior authorization of a prescription for a non-preferred Thyroid Hormone, the determination of whether the requested prescription is medically necessary will take into account whether the member:

1. For a non-preferred Thyroid Hormones, has a history of therapeutic failure of or a contraindication or an intolerance to the preferred Thyroid Hormones; **AND**
2. If a prescription for Thyroid Hormones is in a quantity that exceeds the quantity limit, the determination of whether the prescription is medically necessary will also take into account the guidelines set forth in PA.CP.PMN.59 Quantity Limit Override.

NOTE: If the member does not meet the clinical review guidelines listed above but, in the professional judgment of the physician reviewer, the services are medically necessary to meet the medical needs of the member, the request for prior authorization will be approved.

#### C. Clinical Review Process

Prior authorization personnel will review the request for prior authorization and apply the clinical guidelines in Section B. above, to assess the medical necessity of the request for a prescription for a Thyroid Hormone. If the guidelines in Section B are met, the reviewer

will prior authorize the prescription. If the guidelines are not met, the prior authorization request will be referred to a physician reviewer for a medical necessity determination. Such a request for prior authorization will be approved when, in the professional judgment of the physician reviewer, the services are medically necessary to meet the medical needs of the member.
